

MESSAGE FROM THE CHAIRMAN

Friends of the USG Foundation,

The USG Foundation is dedicated to supporting the work of the University System of Georgia in providing an affordable, quality college education to literally hundreds of thousands of students each year. The USGF Board of Trustees supports this work in many ways, but most significantly in the area of need-based scholarships. The USG Foundation raised more than \$1,494,747 through the Regents' Scholarship Gala and other contributions. Additionally, the Foundation created three new endowments to bring the total endowment portfolio value to \$5,517,862 by the end of the fiscal year. These endowments will provide additional scholarship funds for many years to come.

The USG Foundation also expanded its work in providing support to campus real estate development. A Real Estate Manager Board was formed to better "manage" the Foundation's real estate ventures and investments. Additionally, the Board applied for and was accepted to receive a USDA loan to acquire housing on the Fort Valley State University campus. In the end, student fees remain lower when we are able to keep housing costs down.

The USG Foundation annual report provides detailed information about the Foundation's scholarship awards and endowments, our real estate work, and highlights the Regents' Scholarship Gala. This annual gala is the primary fund-raiser for the Foundation and provides an occasion to recognize outstanding faculty, alumni and friends, and honor a lifetime servant of higher education. It is also our "An Evening of Gratitude" and our chance to thank our very generous sponsors and supporters of higher education.

It is with great pleasure that I present to you the 2017 University System of Georgia Foundation Annual Report and to acknowledge those who gave so generously to the USG Foundation this year. I sincerely thank you for your interest in and support of higher education in Georgia.

REAL ESTATE MANAGER

In August 2008, the USG Foundation Board of Trustees created three LLC subsidiaries as a means of bundling construction projects on the USG campuses to achieve the savings associated with larger bond financings. These LLCs are USG Real Estate Foundation I, LLC (LLC II); USG Real Estate Foundation II, LLC (LLC II) and USG Real Estate Foundation III, LLC (LLC III,) of which the USG Foundation was the sole member. All of the projects have a ground lease/rental agreement arrangement and bonds issued by the Georgia Higher Education Facilities Authority (GHEFA). In 2017, the LLCs were comprised of 13 GHEFA projects on 11 campuses at a value of close to \$271 million.

In Fiscal Year 2017, the USG Real Estate Foundation IV, LLC (LLC IV), another LLC whose sole member is the Foundation, acquired housing at Fort Valley State University. The project was acquired at approximately \$41 million through short-term bond financing and a 20-year federal USDA loan at 2.75% interest rate with a ground lease/rental agreement arrangement.

Also in Fiscal Year 2017, the Board of Trustees created a separate Real Estate Manager board to manage the LLC projects. Members of the board are appointed by the full USG Foundation board and serve a 3-year term.





The University System of Georgia Foundation, Inc. was established as a nonprofit corporation under the applicable provisions of the Georgia Nonprofit Corporation Code. The corporation is a voluntary association of individuals and organizations organized exclusively for charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code. The corporation was organized as a cooperative organization of the Board of Regents.



The University System of Georgia (USG) Foundation established the Regents' Awards for Excellence in Education in 2005 to recognize the contributions and achievements of its students, faculty, alumni and distinguished friends and to raise money for scholarships. Now in its fourteenth year, the Regents' Scholarship

Gala, as it is now known, continues this tradition of honoring the USG family's finest while raising unprecedented funds for scholarships.

FISCAL MANAGEMENT SERVICES

PRIVATE GRANTS

The USG Foundation provides fiscal management for private grants administered by the USG System Office in partnership with USG institutions and USG Education Agency partners. During FY 2017, these grants included:

Credit When Credit is Due

Funder: The Lumina Foundation Administered by the USG Office of Educational Access and Success to increase degree attainment in Georgia through policy changes and technical support to award reverse transfer Associate degrees.

Complete College Georgia Phase II

Funder: The Bill and Melinda Gates Foundation Administered by the USG Office of Educational Access and Success, the project will develop and begin implementation of a framework which would address policies and issues that impede graduation rates.

Hispanic/Latino College Completion

Funder: The Goizueta Foundation Administered by USG Academic Affairs to improve access and success in higher education for Latinos/as in Georgia.

Multi-State New Models Engagement: Building Momentum

Funder: The Bill and Melinda Gates Foundation Administered by the USG Office of Educational Access and Success, the project convened senior academic leaders from ten state systems to establish relationships that would enable increased collaborative understanding of, and approaches to, rapidly emerging opportunities e.g. Massive Open Online Courses (MOOCs) and shared problemsolving and co-development of responses and policy.

Network to Transform Educator Preparation

Funder: The Bill and Melinda Gates Foundation Administered by Council of Chief State School Officers in collaboration with the Georgia Department of Education, the Georgia Professional Standards Commission and the University System of Georgia to provide on-going support and continued coordination to advance the state's educator preparation transformation agenda.

Walk Georgia and Georgia Shape

Funder: The Coca-Cola Company
Administered by the Georgia Department of Public
Health and the University of Georgia this grant uses a
two-pronged approach to address childhood obesity and
encourage healthy lifestyles through preventive care,
disease care, and early intervention.

New Teacher Assistance Grant Mentoring Project

Funder: Georgia Power

Administered by the USG Educator Preparation and Policy (EPP) Team, an electronic mentoring program for the 2016-2017 New Teacher Assistance Grant (NTAG) teachers was developed. The EPP Team identified and trained master classroom teachers and educational leaders who mentored the new teachers through this platform and conducted a survey.






